ELIGIBLE BREEDS & REGISTRY:

Eligible Breeds:

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirnechi dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Norrbottenspets*, Peruvian Inca Orchid*, Pharaoh Hounds, Portuguese Podengos (Medio and Grande)*, Portuguese Podengo Pequenos, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis*, Thai Ridgebacks* and Whippets that are one year of age or older and have been registered with the American Kennel Club, the AKC Foundation Stock Service, an AKC recognized foreign registry or that have been granted an Purebred Alternative Listing (PAL/ILP) may be entered. FSS breeds are denoted with asterisks.

FSS Breeds are not eligible for BIF.

Hounds disqualified from AKC, ASFA or CKC Field Trials are ineligible to compete until recertified.

LURE COURSING TESTS OFFERED:

Junior Courser – Hounds must be one year of age or older. They run alone, once.

Qualifying Courser. The qualifying hound will run with another hound, completing a minimum of a 600-yard course with a minimum of 5 turns. The qualifying hound must complete the entire course with enthusiasm, without interruption, and without coursing, interfering with, or aggressing on the other hound. Owner of the qualifying dog must provide or arrange for a hound of like running style for their hound to run within this test.

LURE COURSING TRIAL STAKES OFFERED:

Open Stake - Open only to eligible hounds that hold an AKC QC certificate; *OR* have an ASFA or CKC field champion title. A copy of the FCh title must be attached to the entry form if the QC requirement is to be waived. Championship points are awarded from this stake.

Specials Stake - Open to all eligible hounds that have earned their AKC FC title. LCX points are awarded from this stake.

Veteran Stake - Championship points are awarded from this stake. Open to any eligible sight hound that has met certification requirements, and:

- Sighthounds whose age exceeds six years
- Except Irish Wolfhounds whose age shall exceed five years
- Except Rhodesian Ridgebacks and Whippets whose age shall exceed seven years.

Singles Stake - Open to all sighthoundS including those disqualified to run in other stakes.

ADVISEMENTS – PLEASE READ

- Loveland, Colorado is at a high-altitude (6000 ft above sea level.)
- Due to the high altitude, please ensure your hounds AND you are in top physical condition.
- Sunscreen and lots of water are strongly recommended.
- The field is <u>NATURAL TERRAIN</u> tending to be dry, uneven ground with a few patches of plants, goatheads, and some rocks. Care is taken to remove rocks and holes from the path of the lure. *This is NOT a manicured lawn*.
- The ground can be hard, packed dirt depending on whether it has rained recently. Sandy soil is also present.
- Be sure to check your dog's feet frequently for goatheads, and the condition of their pads.
- You and your dogs will NEED more water than you think is normal due to the altitude, dry conditions, and lack of humidity.
- We do our best to patch holes in the ground from the various wildlife; as well as remove rocks from the path of the lure.
 Participants are encouraged to help walk the field BEFORE the trial to patch holes.
- June can be VERY hot in Colorado. We will provide water and pools to cool your dog. You are encouraged to bring your own as well.
- Because Sunrise Ranch is in the foothills of the Rocky Mountains, weather can be inclement. We recommend bringing rain gear, warm jackets, hiking boots, gloves, hat, and clothing for cooler weather.

Trial Information:

- 1. AT INSPECTION
 - BITCHES IN SEASON WILL BE EXCUSED and REMOVED from the trial site. Entry fees shall be refunded.
 - b. LAME HOUNDS WILL BE EXCUSED. Entry fees shall be refunded.
 - c. Each entry will be examined at Inspection for breed disqualifications.
- d. All open whippets will be measured at Inspection.
- 2. Spayed or neutered hounds, without breed disqualifications, may be entered.
- 3. MONORCHID OR CRYPTORCHID HOUNDS MAY NOT BE ENTERED.
- 4. All entries must be one year of age or older on the day of the test/trial.
- 5. Incomplete, unsigned, conditional, or unpaid entries will not be accepted.
- 6. The Club, Committee members and/or Trial Secretary assume no responsibility for wrong or incomplete information given on the entry form by the owner or agent of the owner. The Club and/or the Trial Secretary assume no responsibility for the owner or owner's agent for entering a dog in a stake in which the dog is not eligible to compete.
- 7. The Club and/or the Trial Secretary assume no responsibility for a dogs' failure to recall.
- Changes, additions, or corrections to entry forms must be received in writing or by electronic mail prior to the close of entries. Those received by telephone are not acceptable.
- No entry fees will be refunded if the Test/Trial cannot open or be completed by reason of
 riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God,
 public emergency, act of a public enemy, strikes, or any other cause beyond the control of
 the Club or the Field Committee.
- 10. Dogs must be ready for judging. Judges need not wait for dogs holding up a stake. Judges can and may apply a penalty for course delay.
- 11. All trial hounds will run twice, in trios if possible, or braces unless excused, dismissed, or disqualified.
- 12. Running orders will be posted each day.
- 13. Hounds not present at the time of Roll Call will be scratched after a 5-minute grace period. Fees will not be returned for absenteeism.
- 14. Muzzles are not required but are permitted at the handler's discretion.
- 15. Entry fees shall not be refunded in the event that a dog is absent, disqualified or dismissed by a judge, barred from competition by action of the Field Committee.
- 16. There will be a \$10.00 fine assessed for any loose dog on the field but not taking part in the course in progress.
- 17. Field Committee reserves the right to bar aggressive dogs and bitches in season from the event site.
- 18. Persons or dogs exhibiting conduct detrimental to AKC will be asked to leave the trial site.
- 19. The Club, Field Committee, their agents, employees, etc., assume no responsibility for any loss, theft, damage, injuries, or death sustained by exhibitors or handlers to any dog or property, and further assume no responsibility for injury to children while at or on the Trial grounds, or in transit to/from the Trial grounds. It is recommended that small children be kept back off the field where the course is laid, and dogs are running to minimize risk.
- 20. Mixed stakes requests must include agreement from all exhibitors in that breed and the request must be made prior to the draw. Mixed stakes will then incorporate all hounds for

- that breed into one draw. Otherwise, there is no combining of courses or trading of draw placements amongst exhibitors. These are AKC rules. The draw order must be random.
- 21. Only those hounds who are participating in the QC test will be granted the 15 minutes to enter after the QC test. All other hounds must be entered by gate closing. If you plan to QC your dog AND enter the trial in the same day, please inform the Field Secretary of your intentions so as to make the paperwork go smoother.
- 22. The field committee reserves the right to make corrections to this premium as needed.
- 23. Practice runs can be done after the event is completed if equipment and weather conditions allow. Practice runs are \$5/run.

VACCINATIONS

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Please have a current rabies certificate available for each hound present. Rabies vaccination should be current, as required for the state you live in.

- BRING WATER AND SHADE FOR YOUR HOUNDS.

- Bring Sunscreen!!
- Due to dry conditions, smoking of any kind is prohibited on the field, Absolutely NO CAMPFIRES!
- PICK UP AFTER YOUR DOG AND YOURSELF!
- EQUIPMENT: Type of lure machine: battery-powered continuous-loop system. Back-up equipment will be available. Type of lures: highly visible plastic strips.
- A \$40.00 fee will be assessed for any returned checks. Persons exhibiting conduct detrimental to AKC/RMBC/CRRC/ any hound(s)/other person(s) will be asked to leave the trial site.
- There will be a \$5.00 fine for any owner who does not clean up after his/her hound and for any loose hound not competing in the course in progress.

How To Enter

- 1. Complete the entry form(s) one entry form for each dog and each day that the dog is entered.
 - a. If this is the first time you have entered this dog in an AKC trial, AND your dog has an AKC QC (qualified courser) OR an ASFA Certification, you MUST include a copy of that with your entry.
 - b. If your dog does NOT have an AKC QC or ASFA Cert, you are allowed to run in SINGLES, but not the regular open stake. We offer certification AFTER the trial (Friday and Saturday ONLY.) Certification forms are included.
- 2. Email your entries <u>AND</u> the COVID waiver to the Field Trial Secretary at <u>kdarci@yahoo.com</u> ENTRIES THAT ARE EMAILED MUST BE ACCOMPANIED BY PAYMENT THROUGH PayPal see #3 for more details.
 - a. You can mail your entries and PAYMENT to the Field Trial Secretary. Due to COVID-19 mail is taking 3-4 days LONGER than normal! Please note no signature required packages will be accepted! Due to limited entries, EMAIL entries are strongly encouraged. Entries are on a first-come, first-served basis.





Lure Coursing Procedures

We will follow the State of Colorado and all local guidelines.

- 1. All Field Committee and Lure Operators will wear facial coverings.
- 2. All participants will wear facial coverings when interacting with people not in their household.
- 3. All participants shall maintain the 6-foot social distancing requirement when interacting with people not in their household.
- 4. No food will be provided. Please bring your own water and shade for yourself and your dogs. None will be available.
- 5. Park at a 6-foot distance away from other vehicles.
- 6. Roll Call will be done at everyone's car, instead of at a central location. The roll call committee will wear facial coverings. We will ask the owners of females to wipe their dogs and show the inspection committee the tissue.
- 7. Wickets will be wiped down after each dog.
- 8. Hand sanitizer and wet wipes are provided. You are encouraged to bring your own.
- 9. We will prop open the port-a-pot when not in use for more air flow to cut down on bacteria.
- 10. Huntmasters will stand 6 feet from the dogs after inspecting blankets and slip leads.
- 11. At the starting line, all dogs will stand 6 feet apart.
- 12. Practice social distancing the best you can. I know we all have been cooped up but act responsibly!!
- 13. Please be aware of the running order posted; we will use a bull horn to notify you if you choose to stay by your car.
- 14. We will also post running orders and scores on our Facebook page.
- 15. No self-serve ribbons or prizes due to cross contamination.
